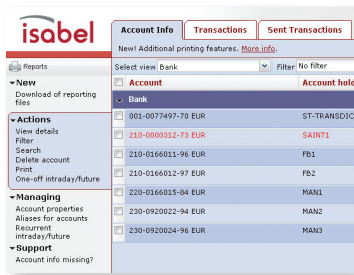

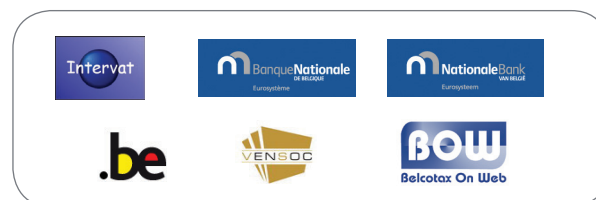
Isabel 6 is more than just banking.

You can sign declarations electronically and submit these to the authorities, e.g.

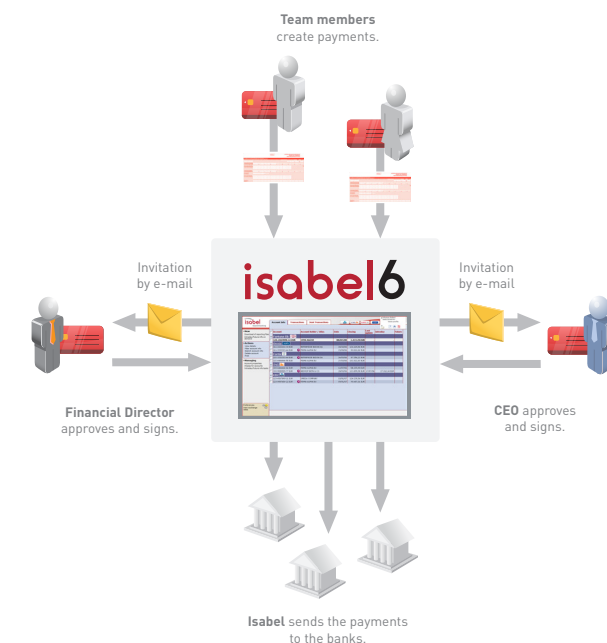
- the electronic VAT declaration (Intervat)
